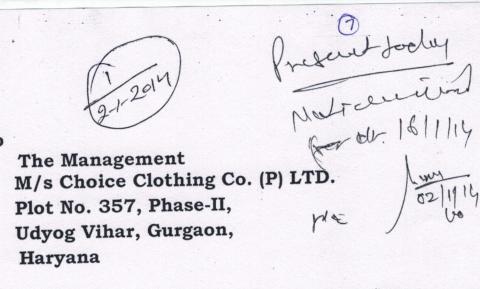

Subject: Demand Notice under Industrial Dispute Act 1947, Section 2A against illegal and unjustified termination of below mentioned workman.

It is respectfully submitted,

- 1. That the abovementioned workman, Smt. Pushpa Devi, S/o-Surendra Singh resident of House No.2, Shyam Vihar, Phase-2, Dindarpur, Nazafgarh, New Delhi has been employed with M/s Choice Clothing Pvt. Ltd. As tailor. She has been appointed as tailor in production deptt. of the company. But later on, she has been transferred in Part Change (Alteration) Of the company. The workman was working regular/permanent workman continuously as a 01.09.2000 with monthly salary of INR 6000 with full honesty and integrity.
- 2. That the Management has terminated the workman on 10.12.2013 against norms of Industrial Dispute Act, 1947 which is unlawful, unjustified and illegal. The Management neither issued any charge sheet nor ordered for any domestic inquiry for the stated issue. Management did not complied with section 25-F of the Industrial Disputes Act, 1947, while terminating workman. The deed of the Management was not only illegal but also against the Labour laws and natural justice.
  - 3. That on dated 23-11-2013, when workman was performing her duty at shop floor, she was commented and abused by master

of Part Change deptt. Mr. Rajkumar. She opposed his words and complained personnel deptt. About her abusive language. But instead of action against master Rajkumar, personnel deptt. Officials threatened to terminate her. After some days, she has been terminated by the management without citing any reason and in consequence of complaining against her master for abusive language.

- 4. That the management did not give her any opportunity of hearing. She has repeatedly requested to not terminate her as she was never intended to leave this job and did not committed any such mistake, which may be reason of her illegal termination. But management did not pay any heed on her genuine demands.
- 5. That the above mentioned workman has already completed the tenure of 240 days in the said company hence he is eligible for all Labour rights under Industrial Dispute Act, 1947 and other Labour laws.
- 6. That the management has not yet paid the earned wage of the workman till date. She has been repeatedly called by the management for clearance of his earned wage but was never paid the same by the management. The management has intentionally harassed the workman mentally and economically.
- 7. That the management did not paid her gratuity, earned wages, leave encashment, retrenchment compensation and back wages yet.
- 8. That the workman is still unemployed since she has been terminated from the company by the management.

Therefore it is demanded that,

- The management reinstates the above mentioned workman with back wages and continuity in service immediately.
- The Management makes all the payments due till date to the abovementioned workman without delay.
- The Management fulfills the above demands without any delay otherwise we would go to Labour court for justice and the management would be liable to bear all expenses for the same.

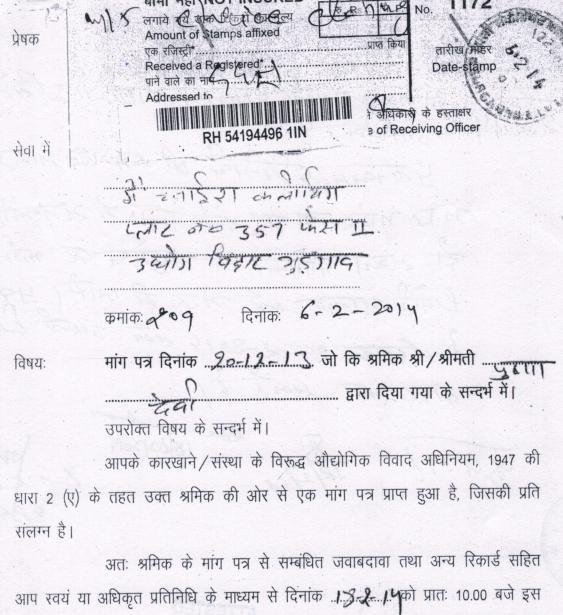
