

Copy of letter No.2/11/IOWB dated 27th August 1965 from the Office of the Central Wage Board for Iron Ore Mining Industry 13, Lindsay Street, 2nd floor, Calcutta-16 regarding hearing and visits to the mines of the Iron Ore Mining Wage Board in the Souther region of the country.

You were informed that the meeting of the Central Wage Board in the South is starting from 13th September 1965, at Bhadravati. The programme of the Board has undergone a change. The Board is starting its work at Bhadravati from the morning of 27th September, 1965. It is leaving for Hospet on the afternoon of 28th, reaching Hospet at about 8 P.M. on 28th September. The Board is visiting the mines in the Hospet area on 29th September from 8 a.m. to 3 p.m. The parties will be heard at the Vaikunt Guest House (on the side of the old Madrag State on the hill near the temple) from 4 p.m. on the same day i.e. 29th Septe,ber.
